PP101, Basement Plumbing Plans:

Key notes #9 and #11 are to make contractor aware that these areas will be congested and require a degree of field coordination with General Contractor for both installation, and temporary construction barriers and service outage scheduling. Architectural plans will be updated to reflect ceiling in many of these areas to be fully replaced, in areas not showing full ceiling removal/replacement the contractor will be expected to take precautions to protect existing ceiling tiles and tee supports from damage.

PP101, Basement Plumbing Plans:

Key note #10 indicates that most areas have an existing plaster ceiling above the current lay-in tile ceiling systems. Project requirement will be to fully remove all of those existing plaster ceilings where new piping work is indicated on drawings. Current asbestos report indicates that those plaster ceilings are free of hazardous materials and can be demolished by contractor within their submitted bids.
