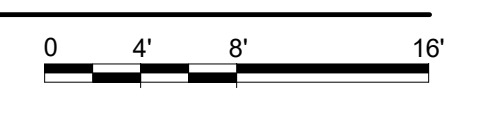

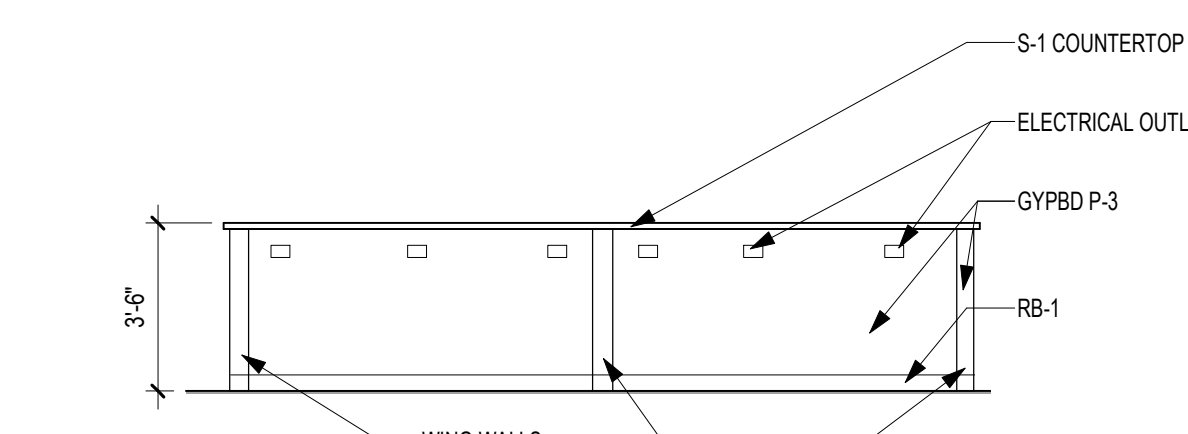
2 ELEVATION - OFFICE 149 - EAST
