Johnson Control has the sole owner of the intellectual property and has the contract for the Sioux Falls VA Health Care System DCS and all new equipment must be compatible with the MetaSys DCS and must be installed by a certified Johnson Control technician.
 - Overall, due to the contract with the associated intellectual property, Johnson Control is the sole provider legally capable of installing the new control programming.
- 4. Description of market research conducted and results or statement why it was not conducted: Market research was not conducted for the Sole Source Selection. The reason for not conducting market research is that due to the contractual obligations with Johnson Control and their sole ownership of the intellectual property associated with the equipment, Johnson control is the only authorized company that can provide the programming services needed for this project.
